**Item 2 ACT ON CONTRACTS FOR DEPUTIES**

Sheriff Ouellette presented the deputy contracts for Parsonsfield, Acton and Shapleigh for the Commissioners' approval and signatures.

Commissioner Sinden moved to approve the contracts as presented. Commissioner Cabral seconded the motion. Vote 3-0 (Commissioner Dutremble not yet present).

**OTHER ITEMS**

The County Manager discussed a worksheet from Barry Tibbetts regarding allocation of costs for the Sheriff's department. He stated that he feels it's important to start formulating a game plan for possible future legislation.

Commissioner Sinden commented that he is uncomfortable with the Commissioners getting involved in this conversation. He added that the

Commissioners don't work for the towns in this sense. This is a question for the towns and is something they should agree on if they so desire, stated Commissioner Sinden. The towns should then bring this issue to the Advocacy Group and then the Commissioners would go to Augusta and testify and give their opinion. He feels that the Sheriff has the solution in having the towns contract a deputy. Commissioner Dutremble stated that he agrees with the County Manager that we should formulate a plan.

**Commissioner Cabral motioned to enter into executive session. Commissioner Dutremble seconded the motion. Vote 4-0.**

County Manager Zinser informed the Commissioners that Bob Bohlmann will step down as Interim EMA Director effective December 1, 2012. Dave Francoeur, Deputy EMA Director, will become acting Director. The goal will be to post the position the first of next year with a hire date in March or April.

**Commissioner Dutremble motioned to appoint Dave Francoeur as Acting EMA Director until a replacement is hired. Commissioner Cabral seconded the motion. Vote 4-0.**

The County Manager recommended that the Commissioners allocate monies received from the pre-release center to the technology reserve account and for phase two of the Rick Dacri project.

**Commissioner Dutremble motioned to approve re-allocation of pre-release center funds to the technology reserve account and to assist in funding of phase two of the Rick Dacri report. Commissioner Cabral seconded the motion. Vote 4-0.**

County Manager Zinser requested the Board adjust hours for some personnel.

**Commissioner Dutremble approved the adjustment of hours for personnel cited by the County Manager. Commissioner Sinden seconded the motion. Vote 4-0.**
